Purpose

1. Education New Zealand's (ENZ's) quarters one and two report for 1 July to 31 December 2023 is attached for your information.

Background

2. The report provides an overview of ENZ's first and second quarter performance for 2023/24 against the intentions stated in ENZ's *Statement of Intent 2023-2027*, *Statement of Performance Expectations 2023/24*, ENZ's 2023/24 Business Plan, and the then Minister of Education's Letter of Expectations.
3. The Quarter Report also speaks to the new Government's priorities for international education. The details are outlined in the attached Report.
4. In January 2024, the Board decided that the Quarter One and Two periods would be combined into a single report given the timing of the incoming government and the long period that had elapsed since the period covered by the Quarter One report. Consequently, this is the first of ENZ's quarterly reports that outlines how ENZ is tracking against the 2023/24 Business Plan.
5. The report was provided to ENZ's monitoring agencies (Ministry of Education and Ministry of Business, Innovation and Employment) for consideration.
6. ENZ's Board recently reviewed the Quarter One and Two report and approved providing the report to you.
